



## Oral Abstract Presentations FAQ

### 1. When and where is Adherence 2023 taking place?

Adherence 2023 will take place June 11-13, 2023, at El Conquistador resort in Fajardo, Puerto Rico. Presenting authors must be registered for the conference. If you have not already registered, you may do so by [clicking here](#).

### 2. How do I make hotel accommodations?

### 3. Will Adherence 2023 have a virtual component?

No, Adherence 2023 will not have a virtual component. Adherence 2023 will be hosted full in-person. PDFs of select presentations will be available to view at the end of the conference, but there will **NOT** be any recordings of the presentations.

### 4. May I present my abstract virtually?

No, you may not present your abstract virtually. As Adherence 2023 is fully in-person, there will not be a livestream component to allow for virtual presentation. Therefore, all abstracts presented at the conference must have an in-person presenter.

### 5. How long do I have to present my abstract?

All abstract presenters will have their time allotments communicated to them by **April 21, 2023**. Please check your “Spam” or “Junk” folders, and please be sure to check with the person who submitted your abstract as all communications will be sent to them unless they have asked for the point of contact to be updated.

### 6. When and where is my abstract scheduled for presentation?

All abstract presenters will have the schedule and room location of their abstract session communicated to them by **April 21, 2023**. Please check your “Spam” or “Junk” folders, and please be sure to check with the person who submitted your abstract as all communications will be sent to them unless they have asked for the point of contact to be updated.

**7. Is there a PowerPoint template?**

**8. When do I need to submit my presentation?**

Adherence 2023 is a CME/CE accredited conference. Therefore, all abstract presentations must have a draft submitted by **May 12, 2023**. Edits may continue to be made to the submission, but the draft is required by **May 12, 2023**, by the accrediting authority. Final submissions **must be uploaded** to the folder at the end of this answer by **May 31, 2023**. Failure to upload the presentation by **May 31, 2023**, may result in the abstract not being presented. This lead time is required by the production team to run through all of the presentations and ensure there are no errors ahead of the conference start date. Keep in mind that there will be over 100 presentations that the production team must check for quality, which is why delays cannot be permitted. [Upload your presentation by clicking here.](#)

**9. Do I need to complete any forms as a presenter?**

As a conference presenter, Montefiore Medical Center will contact you to complete a disclosure form. This is to ensure that the conference maintains its accreditation. Please check your “Spam” or “Junk” folders for the email if you do not see it in your inbox by the end of April 2023.

**10. What other information do I need to provide?**

Please share the name, degrees, title, affiliation, and city, state, and country of the presenting author. This is necessary so that the abstract session moderator can appropriately reference the presenting author to the audience ahead of their presentation.
