Background:

- 15% of Miami-Dade County's population is Black, however the Black community accounts for 27% of people living with HIV in the county as of 2022 (FDOH)
- Structural barriers to healthcare may drive lack of access to preventative care for HIV
- Race-related discrimination has been found to be linked to structural barriers to care and mental health symptoms such as anxiety

Five Point Initiative Bundled Implementation Strategy

A hybrid type 2 cluster randomized trial (using a stepped-wedge design) is being conducted to evaluate the effectiveness and implementation of FPI BIS.

- Coordinate outreach events in local venues
- Community residents engaged on a brief survey and provided with HIV testing and PrEP information, screening, and linkage (if indicated)

- 3,240 community members in Miami, FL
- Recruitment between February and December 2024
- Pre-intervention phase of FPI BIS

Methods: Statistical Analyses

- Two network analyses were conducted using polychoric correlations:
 - 1. Being treated with a lack of courtesy or respect (1,235 pts indicated)
 - 2. Being threatened or harassed (544 pts indicated)
- Network analyses included the following for all participants sampled:
 - Total number of barriers experienced
 - Average of how often they experienced mental health symptoms in the past two weeks
 - Reasons for why they experienced discrimination
- Edge weight significance was used to determine significant relations between network nodes
- Analyses were conducted in RStudio using: qgraph, glasso, bootnet





Results Network 1: Network


- Central lity

 - Second most central node in strength, closeness, and betweenness: experiencing discrimination due to living with HIV






Results Network 2: Being Threatened






Results Network 2: Network Centrality

Discussion

- Majority of participants who experienced discrimination were Black, low SES, heterosexual males
- Community residents in Miami, FL who are experiencing discrimination are also experiencing mental health symptoms more often and more structural barriers to healthcare
- Discrimination, structural barriers, and mental health within the Black community must all be addressed to increase access to HIV prevention services
